

RESOLUTION NO. 210224 MAR 26 1974

WHEREAS, the City Council, by Resolution No. 209345 dated November 27, 1973, authorized the Mayor to submit an application to the American Revolution Bicentennial Commission in Washington, D. C. for authorization to create locally the San Diego American Bicentennial Committee (herein called "Committee"); and

WHEREAS, said application has been filed to establish the Committee for the purpose of acting as the central bicentennial planning and coordinating group for The City of San Diego pursuant to the program activity schedule set forth in Attachment A to Resolution No. 209345; and

WHEREAS, it is now necessary to provide funds and services in order to establish and activate the local Committee for the remainder of fiscal year 1974; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby fully authorized to provide a project coordinator and support services as required and set forth by the San Diego American Revolution Bicentennial Committee for promotion, coordination and organization of community participation in the nation's 200th birthday.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to expend from the Transient Occupancy Tax Reserve Fund 224 an amount not to exceed \$7,650 during the balance of fiscal year 1974 for such purpose.
