

RESOLUTION NO. 210235 MAR 26 1974


WHEREAS, the City Council by Resolutions No. 210233
and 210234, adopted MAR 26 1974,
designated a redevelopment survey area known as the Southeast
Redevelopment Survey Area and directed the Planning Commission to
select a project area and formulate a preliminary plan for the
project area; and

WHEREAS, there may be several appropriate project areas within
the designated survey area in addition to the project area to be
generally bounded by State Route 94, Wabash Boulevard, Market Street
and 32nd Street; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of The City of San Diego
as follows:

That the City Planning Department and Redevelopment Agency
staffs are hereby directed to investigate the feasibility of
additional redevelopment project areas within the Southeast
Redevelopment Survey Area and to develop time priorities for the
establishment and development of any such additional redevelopment
project areas.
