

RESOLUTION NO. 210236 MAR 26 1974

WHEREAS, by Resolutions No. 210233, 210234
and 210235, adopted MAR 26 1974, the City
Council designated a survey area known as the Southeast Redevelopment
Survey Area and directed the Planning Commission to select a project
area and to formulate a preliminary redevelopment plan, and directed
the City Planning Department and Redevelopment Agency staffs to investi-
gate the feasibility of additional redevelopment projects in the
Southeast Redevelopment Survey Area; and


WHEREAS, special legal counsel and financial feasibility
consulting services will be required in connection with the above
actions; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that
the City Manager is hereby authorized and directed to transfer
fifteen thousand dollars (\$15,000) from the Federal Revenue Sharing
Fund 2383 to the 982 Redevelopment Agency Revolving Fund for special
legal counsel and financial feasibility consulting services.
