RESOLUTION NO. 210237 MAR 26 1974

WHEREAS, the City Council declares its grave concern regarding the smog problem in the San Diego area; and

WHEREAS, it is noted that the San Diego County Board of Supervisors, acting as the Air Pollution Control Board, has scheduled a hearing for March 29 to consider a six-month extension of deadlines for compliance with its rules requiring that area service stations install effective gasoline vapor recovery systems by July 1, 1974; and

WHEREAS, it is noted that the rules already provide for an appeal process for fair and equitable disposition of individual appeals; and

WHEREAS, it is also noted that the proposed new extension, and any other amendments which would weaken the present rules, would jeopardize the County's program to meet State and Federal requirements for air quality improvement by 1977;  
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the Board is urged to reject any proposed amendment of the rules which would further extend compliance dates or permit installation of other than the currently required gasoline vapor recovery systems.

BE IT FURTHER RESOLVED, that the Board of Supervisors is requested to adopt a schedule that would permit individual station owners to comply with the regulations based upon their ability to amortize the cost of compliance in accordance with their volume of sales so as to achieve complete compliance by 1977, and the station owners be permitted to do so by adjusting a price increase not to exceed one cent (\$.01) per gallon.
