


**RESOLUTION No. 210238**

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$200,416.50 by Griffith Company, a corporation, for IMPROVEMENT OF LINDA VISTA ROAD, VIA LAS CUMBRES TO TAIT STREET, including Alternate A, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 746238.
2. That the expenditure of \$159,100.00 is hereby authorized out of Gas Tax Fund (Fund No. 220) and that the expenditure of \$2,000.00 is hereby authorized out of Capital Outlay Fund (Fund No. 245) of the City of San Diego solely and exclusively for the purpose of providing funds for IMPROVEMENT OF LINDA VISTA ROAD, VIA LAS CUMBRES TO TAIT STREET, including Alternate A, in the City of San Diego, and related costs.
