
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the petition for the construction of certain improvements at various locations in PACIFIC HIGHLANDS UNITS NO. 1 and NO. 2, under the provisions of the Improvement Act of 1911, consisting of five sheets and filed under Document No. 746857, is hereby granted.

That the City Manager be and he is hereby directed to prepare plans, drawings, typical cross-sections, profiles and specifications for the improvement by the installation of safety lighting on ornamental standards at various locations in PACIFIC HIGHLANDS UNITS NO. 1 and NO. 2, in the City of San Diego, together with estimates of the costs and expenses of such work and to furnish this Council with a description of the district to be included in the assessment for the work and improvements hereinabove mentioned.
