- 1. That the City Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$52,000 from Federal Revenue Sharing Fund (2381) to the Capital Improvement Project 23-672(1) for the purpose of constructing a fieldhouse at Cabrillo Playground.
- 2. That the City Auditor and Comptroller be and he is hereby further authorized to transfer the sum of \$52,000 from the Park and Recreation Bond Fund (725) to the Capital Improvement Project 23-751(4) for the purpose of completing the Phase II development at Azalea Community Park.
