

RESOLUTION NO. 210254 MAR 28 1974

WHEREAS, the Cabrillo Playground Fieldhouse project was approved as part of the 1966 Park Bond Fund election; and

WHEREAS, this project is to be located on leased property and as a result thereof, such Park Bond Fund monies may not be legally expended therefor; and


WHEREAS, it is desired to effect a transfer of funds so that the project may be completed as scheduled through the application of federal revenue sharing monies; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$52,000 from Federal Revenue Sharing Fund (2381) to the Capital Improvement Project 23-672(1) for the purpose of constructing a fieldhouse at Cabrillo Playground.

2. That the City Auditor and Comptroller be and he is hereby further authorized to transfer the sum of \$52,000 from the Park and Recreation Bond Fund (725) to the Capital Improvement Project 23-751(4) for the purpose of completing the Phase II development at Azalea Community Park.
