WASSERMAN, c/o 5048 54th Street, San Diego, California 92115, to construct certain improvements in INTERSTATE PROPERTIES UNIT NO. 1 subdivision, which agreement is filed in the office of the City Clerk as Document No. 733289; and

WHEREAS, in connection with the performance of said agreement, a performance bond was issued by Surety Company of the Pacific; and

WHEREAS, subdivider has not complied with the terms and provisions of said agreement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That DR. LEONARD G. WAYNE and IRVING Y. WASSERMAN are hereby DECLARED TO BE IN DEFAULT of the terms and conditions of the agreement filed in the office of the City Clerk as Document No. 733289 on September 8, 1970, relating to the improvement of INTERSTATE PROPERTIES UNIT NO. 1 subdivision.

2. That the City Attorney shall cause notice of this declaration of default to be given to the said DR. LEONARD G. WAYNE and IRVING Y. WASSERMAN, and to the said Surety Company of the Pacific.

3. That the City Manager is authorized to complete, or cause to be completed, said public work and improvements in accordance with the terms of said agreement.

4. That the City Clerk is hereby directed to forward a certified copy of this resolution to the County Recorder.
