That the City Auditor and Comptroller is hereby authorized to transfer the sum of \$57,296 from the General Purpose Revolving Fund (534) to the Police Department (Dept. 15.46 - O/A 1151) for the purpose of providing paid overtime for officers assigned to the Integrated Narcotics Task Force.

BE IT FURTHER RESOLVED, that these funds shall be reimbursed to The City of San Diego by the United States Department of Justice, Drug Enforcement Administration, pursuant to their letter of authorization dated March 6, 1974, on file in the Office of the City Clerk as Document No. 746879.
