

RESOLUTION NO. 210284 APR 2 - 1974

WHEREAS, Ordinance No. 11254 (New Series), amending Section 22.0101 of the Municipal Code establishing permanent rules of procedure governing the operation of the Council, was adopted on February 28, 1974; and

WHEREAS, Rule 10 of said ordinance established four standing committees of the City Council; and

WHEREAS, Rule 13 of said ordinance provides that the Mayor shall appoint the membership of each committee, subject to confirmation by the Council, except that the Mayor and Deputy Mayor shall serve as permanent voting members of the Rules Committee; and

WHEREAS, Rule 13 provides further that the Mayor shall appoint the chairman and vice chairman of each committee, subject to the confirmation of the Council, except that the Mayor shall serve as permanent chairman of the Rules Committee and the Deputy Mayor shall serve as permanent vice chairman of the Rules Committee; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the following appointments by the Mayor pursuant to Section 22.0101 of the Municipal Code of The City of San Diego to Council committees as indicated for terms ending December 1, 1974, are hereby confirmed:
