

RESOLUTION NO. 210288 APR 2 1974

WHEREAS, the City Manager has proposed a schedule of fees to be charged for processing Environmental Impact Reports and Negative Declarations for private projects; and

WHEREAS, the City Council should approve said schedule by resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the following schedule of fees submitted by the City Manager be and the same is hereby approved.

FEE SCHEDULE

Fees or deposits as set forth herein are established to cover the cost and expense of processing environmental assessments or environmental impact analyses and preparing the Environmental Impact Reports or Negative Declarations. Such fees or deposits as stipulated herein shall be paid at the time of submission of the environmental assessment or environmental impact analysis to the Environmental Quality Department.

The following fee schedule shall apply:

- a. Submission of an environmental assessment and processing of subject assessment into a Negative Declaration \$125
- b. Submission of an environmental assessment and processing of subject assessment into an Environmental Impact Report . . . \$250

c. Submission of an environmental impact analysis and processing into an Environmental Impact Report \$400

d. Where, in the opinion of the Director of the Environmental Quality Department, the proposed project is of sufficient magnitude to warrant the placement of a deposit in lieu of the aforementioned fees, a deposit of \$400 shall be placed with the application for processing of the environmental impact analysis, to which will be charged the time and materials involved in the review process, noticing and such appeals that may be filed. Prior to the filing with the Planning Commission of the Environmental Impact Report, the applicant shall place an additional deposit to cover those costs in excess of an initial deposit as may be necessary to cover those costs incurred by City.

BE IT FURTHER RESOLVED, that Resolution No. 207068 adopted December 14, 1972, be and it is hereby rescinded.
