Lance C. Muller	PUBLIC WORKS DEPARTMENT Traffic Engineering	\$15	Mr. Muller, an Engineering Trainee, was distressed by the number of traffic cones that were lost or damaged around traffic counters. He devised a method of reducing losses by fastening them to the pavement. This has been found to save \$150 per year worth of cones.
Alvin A. Beckett	POLICE DEPARTMENT	\$15	Police Officer Beckett proposed an improved routine for handling applications for cabaret and dance licenses. This has been adopted for a saving of \$147 per year in the time of the several people involved.
Lyla L. Olson	AUDITOR & COMPTROLLER	\$10	Senior Account Clerk Lyla Olson questioned a semi-annual data processing run use. She found it was no longer needed and suggested its discontinuation. This saves \$85 per year for six sets of this run, plus the handling and storage of the documents.
