BE IT RESOLVED, by the Council of The City of San Diego as follows:

That said Council urges the Department of Food and Agriculture of the State of California and the Board of Supervisors of the County of San Diego to seek all means of eradication other than the use of insecticides, but if it is determined that the use of insecticides is necessary, then to provide maximum precautions to protect the health and safety of citizens of and visitors to San Diego in regard to the Japanese Beetle Eradication Control Program, said precautions to include the following:

- 1. Community-wide publicity to be given the eradication program; said publicity to include a description of the techniques used in the program and potential hazards to human beings and other forms of life.
- 2. The dissemination of notices which describe the project, materials, health effects, requisite safety precautions, and responsible State and County officials to contact regarding grievances resulting from the implementation of the program.
- 3. The hand delivery of said notices to residents forty-eight (48) hours in advance of the spraying of pesticides as well as one (1) hour in advance of the spraying of pesticides.
- 4. The scheduling of spraying, if any is determined necessary, within Balboa Park in such manner as to minimize inconvenience to the public, and the providing of adequate posting, cordoning off and patrolling of said park throughout the period during which a health hazard exists.
- 5. The provision of careful monitoring in order to ensure that the frequence, volume and concentrations of pesticides are commensurate with actual beetle infestation and public health considerations.
- 6. Providing the Mayor and City Council with a yearly review of project experience and future plans prior to implementation of annual pesticide program.
