


RESOLUTION No. 210295

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That Resolution No. 209608 adopted January 8, 1974 which approved plans and specifications filed in the office of the City Clerk on November 14, 1973 as Document No. 745435 is hereby amended to authorize the approval of the amended plans and specifications documented on March 19, 1974 as Document No. 746661 and issued on and after January 9, 1974 for IMPROVEMENT OF SORRENTO VALLEY ROAD.
2. That the bid of \$80,877.50 by Griffith Company, a corporation, for IMPROVEMENT OF SORRENTO VALLEY ROAD in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 746661.
3. That the expenditure of \$80,000.00 is hereby authorized out of Gas Tax Funds (Fund No. 220) of the City of San Diego solely and exclusively for the purpose of providing funds for IMPROVEMENT OF SORRENTO VALLEY ROAD in the City of San Diego and related costs.
