Said Council hereby finds that that certain map surveyed
by G. B. PHILLIPS, JR., Registered Civil Engineer, entitled "THE
ALAMEDA Being a subdivision of Lot 1 of Bernardo Village Unit
No. 2, in the City of San Diego, County of San Diego, State of
California, according to Map thereof No. 5832, filed in the office
of County Recorder of San Diego County, February 6, 1967 and of
Lot 1 Bernardo Village Clinic, in the City of San Diego, County
of San Diego, State of California, according to Map thereof
No. 5938, filed in the office of County Recorder of San Diego
County, August 11, 1967.", is made in the manner and form prescribed
by law and conforms to the surrounding surveys; that said map and
the subdivision of land shown thereon is hereby approved and
accepted.


BE IT FURTHER RESOLVED, that said Council hereby accepts on

easements listed in paragraphs 1, 2 and 3 of the certificate signed

and subject to the conditions expressed therein.

The Clerk of said City is hereby authorized and directed to
endorse upon said map, as and for the act of the Council, that said

Council has approved said subdivision map; and that those certain easements listed in paragraphs 1, 2 and 3 of the certificate signed by the Owners are accepted on behalf of The City of San Diego, a municipal corporation, all as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
