

RESOLUTION No. 310316

Adopted on APR 4 1974

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That area of the public beach and adjacent waters bounded on the north by the southern boundary of Pueblo Lot 1324, bounded on the east by the Cliffs, and bounded on the south by the westerly extension of the northern boundary of Lot 5, La Jolla Farms Subdivision, is hereby designated as a "Swimsuit Optional" zone wherein nude sunbathing shall be lawful. The City Manager shall place appropriate signs marking the limits of said area.

That this resolution shall take effect and be in force on MAY 18 1974.
