BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with CAMPBELL & ATKINSON, an architectural-engineering partnership, to provide architectural-engineering services in connection with the design and construction of a pedestrian overpass bridging Torrey Pines Road in the vicinity of its intersection with La Jolla Shores Drive, in the City of San Diego, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 746945.

BE IT FURTHER RESOLVED, that the expenditure of \$22,900 is hereby authorized out of Capital Improvement Construction Fund 244 of The City of San Diego, solely and exclusively for the purpose of providing funds for said services and related expenses.

BE IT FURTHER RESOLVED, that it be and it is hereby certified that the information contained in the Environmental Impact Report on file in the office of the City Clerk as E.Q.D. No. 73-7-006C has been completed in compliance with the California Environmental Quality Act of 1970 and the State guidelines pursuant thereto, and that said Environmental Impact Report has been reviewed and considered by this Council.
