

RESOLUTION NO. 210327 APR 4 1974

WHEREAS, The City of San Diego has committed substantial resources to comprehensively planning its Centre City; and

WHEREAS, The City of San Diego Redevelopment Agency has initiated the 15-block Horton Plaza Redevelopment Project; and

WHEREAS, The City of San Diego in coordinating feasibility studies for the Horton Plaza Redevelopment Project has identified substantial transit and parking deficiencies; and

WHEREAS, the City has initiated a comprehensive urban design study for the Centre City area; and

WHEREAS, The City of San Diego desires to study the possibilities for applications of a small scale people mover transit system in Centre City San Diego and, proposed to submit to Urban Mass Transportation Administration (UMTA) an application for a grant pursuant to Resolution No. 208704, approved August 28, 1973; and

WHEREAS, the Comprehensive Planning Organization (CPO) find the proposed study consistent with their regional planning program and endorses the study; and

WHEREAS, said grant application was submitted to UMTA by CPO; and

WHEREAS, CPO desires that City undertake the study required by said grant; and

WHEREAS, the United States Department of Transportation, Urban Mass Transportation Administration has approved CPO's application for a Technical Assistance Grant; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager or his representative be and he is hereby authorized to execute an agreement with CPO for the City to carry out the study for an amount not to exceed \$115,640 to be reimbursed by CPO, the form of said agreement being on file in the office of the City Clerk as Document No. 746972.
