# RESOLUTION NO. 21000 APR 4 1974

WHEREAS, The Council of The City of San Diego adopted Resolution No. 208704 on August 28, 1973 which contained the following recitations:

- 1. The City of San Diego has committed substantial resources to comprehensively planning its Centre City.
- 2. The City of San Diego Redevelopment Agency has initiated the 15-block Horton Plaza Redevelopment Project.
- 3. The City of San Diego in coordinating feasibility studies for the Horton Plaza Redevelopment Project has identified substantial transit and parking deficiencies.
- 4. The City is about to launch a comprehensive urban design study for the Centre City area.

WHEREAS, said Resolution No. 208704 authorized the City through the City Manager to submit an application for a grant for the above described Transportation Study and to secure consultants needed to conduct portions of said study; and

WHEREAS, said Resolution No. 208704 also authorized expenditure of \$52,000 out of Public Transportation Reserve Fund 2571 in support of said study program; and

WHEREAS, based on said general authorization, contracts were signed with consultants on the dates indicated as follows:

1. Contract with BRH Mobility Services in the amount of \$95,200 (executed February 27, 1974) to provide Transportation consulting services necessary for the MAC Transportation Study.

- 2. Contract with BRH Mobility Services in the amount of \$14,000 (executed February 20, 1974) to carry out Phase I of the MAC Transportation Study in advance of UMTA approval so as to allow the overall planning program to proceed on schedule. This cost may be reimbursed the City by UMTA upon a determination that they are eligible study costs.
- 3. Contracts with Wallen Associates in the amount of \$13,000 (executed on September 12, 1973 and January 8, 1974) to provide support for City staff in administering and carrying out the MAC Transportation Study.
- 4. Contract with Rockrise, Odermatt, Mountjoy and Amis (ROMA) in the amount of \$12,500 (executed on February 20, 1974) to provide for appropriate interface between their Centre City Urban Design efforts and BRH's Transportation Study efforts.

WHEREAS, the City Council should ratify said contracts as an obligation of the City and reauthorize expenditure of said \$52,000 for this purpose; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that those certain contracts on file in the office of the City Clerk as Document Nos. 746973 , 746430, 746420, and 746974 be and the same are hereby ratified.

BE IT FURTHER RESOLVED, that the expenditure of up to \$52,000 from the Public Transportation Reserve Fund 2571 in support of the

Centre City Transportation Planning Program be and the same is hereby authorized for defraying the cost of said contracts and to meet cash flow requirements for the UMTA grant.
