- 1. That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City an agreement with ASTEROID CORPORATION for the maintenance and operation of the San Diego Stadium Scoreboard, under the terms and conditions set forth in the form of agreement, on file in the office of the City Clerk as Document No. 746939
- 2. That the expenditure of \$8,000.00 from 256 Fund, Fiscal 74 and \$14,000.00 from 256 Fund, Fiscal 75 of The City of San Diego is hereby authorized, solely and exclusively for the purpose of providing funds for the maintenance and operation of the San Diego Stadium Scoreboard.
- 3. That the City Manager, or his designee be, and he is hereby authorized and empowered to execute Stadium Scoreboard and/or Display Panel Advertising agreements with advertisers, and approving the rate schedule for and the maximum term of advertising agreements.
- 4. That the City Auditor and Comptroller is hereby authorized to transfer 15% of Stadium advertising revenues from the San Diego Stadium Operation Fund 256 to Convention and Performing Arts Center Fund 254 for advertising promotion and to transfer \$8,737.50 from Reimbursable Advertising Services Expense for Fiscal 74, Fund 256.
- 5. That the City Clerk is hereby directed to deliver a certified copy of this resolution, together with the duplicate original and copy of the agreement, to the Property Department for further handling.
