

RESOLUTION NO. 210332 APR 4 1974

WHEREAS, the residents of the Otay Mesa Community being that area of San Diego bounded on the East by Highway 805; on the West by Highway 5; on the North by the County and City limits; and on the South by proposed Highway 75, which abuts the San Ysidro Community Planning area, desire this area to be included in a recognized Community Plan; and

WHEREAS, there presently exists within this described area, the Otay Mesa Property Owner's Association with a membership approximately 400 persons, with an elected fourteen (14) member executive board, representing a cross-section of the civic, social, business and neighborhood organizations, this meeting the representation requirements of Council Policy 600-5; and

WHEREAS, the Otay Mesa Property Owner's Association has requested formal recognition as the Otay Mesa Community Planning Group and also requested the services of the Planning Department in the development of a Community Plan for the Otay Mesa area; NOW, THEREFORE,

BE IT RESOLVED by the Council of The City of San Diego as follows:

The Otay Mesa Community Planning Group be, and is hereby authorized to represent the Otay Mesa Community, and work with the City Manager's office and Planning Department in the development of a long-range community plan, consistent with community goals and objectives, and be responsible for its presentation as well as the coordination of community support for its adoption and effectuation.

The Planning Department is directed to provide the requested assistance in developing a Community Plan for the Otay Mesa Community.

The Planning Commission is requested to include the Otay Mesa Community Plan in the Department's fiscal 1975 work program.
