APPROVING MAP OF DEL CERRO HEIGHTS UNIT NO. 4 SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by J. C. BROWN, Registered Civil Engineer, and entitled "DEL CERRO HEIGHTS UNIT NO. 4 Being a subdivision of a portion of Lot 67 of Rancho Mission of San Diego, in the City of San Diego, County of San Diego, State of California, according to a Partition Map of said Rancho, filed in the office of the County Clerk of San Diego County in Action No. 348 of the Superior Court of said County entitled 'Juan M. Luco, et al. vs. The Commercial Bank of San Diego, et al.'", is made in the manner and form required by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following: a portion of Pasatiempo Avenue and a portion of Del Paso Avenue, for public purposes and said portions of public streets are hereby declared to be portions of public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of water, sewer and drainage facilities, as granted

and shown on said map and subject to the conditions set forth therein.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, those easements listed in paragraphs 1 and 2 of the certificate signed by the owners for general utility purposes and open space, as granted and shown on said map and subject to the conditions expressed therein.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portions of public streets are accepted on behalf of the public as heretofore stated; and those certain easements for water, sewer and drainage facilities, together with the easements in paragraphs 1 and 2 of the certificate signed by the owners are accepted on behalf of The City of San Diego, a municipal corporation, all as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
