RESOLUTION NO. 310357 **APR 11 1974**

WHEREAS, a study recommending an increase in the rates of Automobiles for Hire was reviewed by the Ad Hoc Committee for Taxis and Automobiles for Hire on February 25, 1974; and

WHEREAS, said committee resolved that the matter be placed on the Council docket with a recommendation that the rate increase be approved; and

WHEREAS, the Council should hold a public hearing to consider said recommendation for a rate increase; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Clerk be, and he is hereby directed to place on the Council docket for consideration in a public hearing an amendment to Section 72.21(d) of the San Diego Municipal Code providing a rate increase for Automobiles for Hire as follows:

1. Hourly rates: from \$7.00 to \$10.00.
2. Trip rates: from \$0.65 per mile one way or \$0.35 per mile round trip to \$0.50 per mile one way or round trip with a \$7.50 minimum charge for one trip.

BE IT FURTHER RESOLVED, that the City Clerk give published notice of said public hearing in the usual manner at least one week prior to the date set therefor.
