
Adopted on APR 18 1974

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of the UNITED STATES OF AMERICA, DEPARTMENT OF THE NAVY, executed in favor of The City of San Diego, bearing date of July 24, 1973, conveying to said City an easement and right of way for a public street and public pathway for pedestrian and non-motor vehicular use, being a portion of Lot 23 of Rosedale Tract, according to the Map thereof No. 825, filed January 21, 1897 in the office of the San Diego County Recorder, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named TIERRASANTA BOULEVARD.

That the City Clerk be and he is hereby authorized and directed to file the foregoing said deed for record in the office of the County Recorder of San Diego County.
