

That Change Order No. 1, dated February 13, 1974, heretofore filed with the City Clerk of said City as Document No. 747113, issued in connection with the contract between The City of San Diego and R. S. CONSTRUCTION COMPANY for construction of the Via Siena storm drain, said contract having been filed as Document No. 746394 in the office of the City Clerk be, and the same is hereby approved; and the changes therein set forth, amounting to an increase in the contract price of \$4,651.55 be, and the same are hereby approved; and that the expenditure of \$4,500 is hereby authorized out of Capital Outlay Fund 245 of The City of San Diego, solely and exclusively for the purpose of providing funds for the above project, supplementing Resolution No. 209822 in this amount.

BE IT FURTHER RESOLVED, that the request contained in said Change Order No. 1 for an extension of time of 60 days, to wit, to and including June 6, 1974, in which to complete said contract, be and the same is hereby approved.
