BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the firm of Gray, Cary, Ames & Frye be employed and appointed as special bond counsel for giving an opinion on any bonds that may be issued to pay for the financing and acquisition of approximately 1100 acres of undeveloped canyon and hillside land in Clairemont and Kearny Mesa for seven proposed TECOLOTE CANYON OPEN SPACE PARK ASSESSMENT DISTRICTS under the provisions of the Municipal Improvement Act of 1913 and the San Diego Park District Procedural Ordinance of 1969, pursuant to the terms and conditions set forth in the letter dated March 4, 1974 on file in the office of the City Clerk as Document No. 747118.

That in the event the proposed proceedings described above fail to materialize or are abandoned before assessments have been levied and collected, the City shall be liable for payment for services and costs incurred in said employment in an amount not to exceed \$17,250 in accordance with the terms and conditions of said letter of March 4, 1974.

That the expenditure of not to exceed \$17,250 from Environmental Growth Fund 2505 is hereby authorized in the event the proposed districts fail to materialize or are abandoned before assessments have been levied and collected.
