RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, APPROVING PLANS AND PROFILES SHOWING CHANGES AND MODIFICATIONS IN THE WORK DESCRIBED IN RESOLUTION OF INTENTION NO. 210066 FOR THE IMPROVEMENT OF THE ALLEY, BLOCK 23, KENSINGTON PARK AND THE ALLEY, BLOCK 24, SUNSET CLIFFS.

That the plans, drawings, typical cross-sections, profiles and specifications for the improvement of the ALLEY, BLOCK 23, KENSINGTON PARK, ALLEY, BLOCK 2, UNIVERSITY PLACE AND BLOCK 225 1/2, UNIVERSITY HEIGHTS; ALLEY, BLOCK 24, SUNSET CLIFFS, and 32ND STREET, heretofore filed in the office of the City Clerk as Document No. 746550 and approved by Resolution No. 210065, be,
