RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, ORDERING CERTAIN CHANGES AND MODIFICATIONS IN THE WORK FOR THE IMPROVEMENT OF LOS ALTOS ROAD AS DESCRIBED IN RESOLUTION OF INTENTION NO. 205383.

WHEREAS, this City Council did on April 18, 1972, adopt its Resolution of Intention No. 205383 declaring its intention to order the construction of certain improvements in the City of San Diego; and

WHEREAS, this City Council did on February 26, 1974, adopt its Resolution No. 209961 proposing to make certain changes and modifications in the work as described in said Resolution of Intention; and

WHEREAS, the hearing has been held on said proposed changes, all in the manner and form prescribed by law, and objections not having been made by the owners of one-half of the area of the property proposed to be assessed, and this Council now having jurisdiction to make said changes and modifications; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:
