

**RESOLUTION No. 210402**

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of GRACE CROMWELL, as her sole and separate property, executed in favor of The City of San Diego, bearing date of October 15, 1972, conveying to said City an easement and right of way for a public street and incidents thereto, across a portion of Lot 22, Soledad Terrace, according to the Map thereof No. 1618 filed in the office of the San Diego County Recorder, December 23, 1913, as more particularly described in said deed, be and the same is hereby approved, and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named LOS ALTOS ROAD.

That the City Clerk of said City is hereby authorized and directed to file the foregoing said deed for record in the office of the County Recorder of San Diego County.
