

RESOLUTION NO. 210413 **APR 18 1974**

WHEREAS, LA JOLLA VILLAGE, a joint venture, subdivider of VILLA LA JOLLA UNIT NOS. 2, 4, and 5; and LA JOLLA VILLAGE, a joint venture, and THE MUTUAL BENEFIT LIFE INSURANCE COMPANY, a corporation, subdivider of VILLA LA JOLLA UNIT NO. 3, were required to install certain improvements in said subdivisions under agreements filed in the office of the City Clerk; and
