WHEREAS, the Department of Transportation, State of California, is in the process of acquiring rights-of-way for the purpose of widening of State Highway 94, in the County of San Diego; and

WHEREAS, said proposed freeway widening crosses a portion of Lot 3, Section 7, Township 18 South, Range 3 West, San Bernardino Meridian, according to United States Government Survey approved May 20, 1881, owned by the City of San Diego, and said Department of Transportation, State of California, desires to purchase said City-owned property for said proposed freeway widening; and

WHEREAS, Section 22.0907 of the San Diego Municipal Code authorizes the conveyance of City property to public agencies for public purposes without complying with the provisions relating to the advertising for bids and auction sales contained in the Municipal Code; and

WHEREAS, said Department of Transportation, State of California, has appraised said property, and has offered to pay to the City the sum of one thousand, four hundred dollars (\$1,400) for a grant deed conveying said City-owned property, as more particularly described in said grant deed; and

WHEREAS, said appraisal has been reviewed and approved by * the Property Director of said City; and

WHEREAS, the City Manager, pursuant to Section 22.0907 of the San Diego Municipal Code, has recommended that said property be sold to the State of California for the amount hereinabove recited; NOW, THEREFORE, BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That the City Manager of said City be, and he is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Right of Way Contract State Highway No. 23068 (23075), with the State of California, Department of Transportation, covering the sale by the City to the State of California of a portion of Lot 3, Section 7, Township 18 South, Range 3 West, San Bernardino Meridian, as more particularly described in said Right of Way Contract, for the proposed widening of State Highway 94 in said County of San Diego, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 747136 .

3. That the City Clerk is hereby authorized and directed to deliver said Right of Way Contract and said grant deed, together with a certified copy of this resolution, to the Property Director for further handling.
