

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$66,137.00 by American Electric Contracting Corporation, a corporation, for CONSTRUCTION AND MODIFICATIONS OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT CAMPUS AVENUE, NORMAL STREET, POLK AVENUE AND WASHINGTON STREET; AND MIRA MESA BOULEVARD AND WESTONHILL DRIVE, Schedules I and III, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 746347.
2. That the expenditure of \$82,976.00 is hereby authorized out of Gas Tax Fund (Fund No. 220) of the City of San Diego and that the expenditure of \$2,700.00 is hereby authorized out of Capital Outlay Fund (Fund No. 245) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION AND MODIFICATIONS OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT CAMPUS AVENUE, NORMAL STREET, POLK AVENUE AND WASHINGTON STREET; AND MIRA MESA BOULEVARD AND WESTONHILL DRIVE, Schedules I and III, in the City of San Diego, and related costs.
