RESOLUTION NO. 210445 APR 25 1974

WHEREAS, The City of San Diego is the owner of certain lands affecting portions of Lots 1 and 2 in Fractional Section 13, Township 18 South, Range 1 West, S.B.B.M.; the Northeast Quarter of the Northeast Quarter of said Section 13; and Lots 5 and 6 in Section 18, Township 18 South, Range 1 East, San Bernardino Base and Meridian; and


WHEREAS, the SAN DIEGO GAS & ELECTRIC COMPANY, a corporation, has requested the conveyance of an easement across said lands for the purpose of the construction and maintenance of a gas line to its pumping station in the Otay Mesa area; and

WHEREAS, the purpose for which the easement is required is a public purpose; and

WHEREAS, Section 22.0907 of the San Diego Municipal Code authorizes the conveyance of City property to public agencies for public purposes without complying with the provisions relating to the advertising for bids and auction sales contained in the Municipal Code; and

WHEREAS, the City Manager, pursuant to Section 22.0907 of the San Diego Municipal Code, has recommended that said easement be conveyed to the San Diego Gas & Electric Company, a corporation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:



That, in consideration of the benefits to accrue to the people of said City, and the sum of \$125.00, the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a deed conveying to the SAN DIEGO GAS & ELECTRIC COMPANY, a corporation, an easement for the purpose of constructing and maintaining a gas line across said portions of Lots 1 and 2 in Fractional Section 13, Township 18 South, Range 1 West, S.B.B.M.; the Northeast Quarter of the Northeast Quarter of said Section 13; and Lots 5 and 6 in Section 18, Township 18 South, Range 1 East, San Bernardino Base and Meridian, as more particularly described in the form of deed of easement, on file in the office of the City Clerk as Document No. 747158.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
