

RESOLUTION NO. 210446 APR 25 1974

WHEREAS, The City of San Diego is the owner of a certain easement for sewer purposes across a portion of the Northeast Quarter of the Northwest Quarter, Section 11, Township 15 South, Range 3 West, S.B.M., being a portion of the 20.00 foot wide sewer easement described in Deed recorded September 19, 1961, as File/Page No. 163262 of Official Records of the County of San Diego; and

WHEREAS, the Community Development Department of said City has requested that the City quitclaim to WILLIAM STITES, GERTRUDE MYERS, C.E. JOHNSON, J.R. HOLDER and the LIBERTY NATIONAL BANK AND TRUST COMPANY OF OKLAHOMA CITY, OKLAHOMA, as trustees of the Charles Morton Share Trust, its interest in and to said easement; and

WHEREAS, said sewer easement has been realigned and said easement is not needed for any present or prospective City use; and

WHEREAS, the City desires to negotiate the sale of said easement to WILLIAM STITES, GERTRUDE MYERS, C.E. JOHNSON, J.R. HOLDER and the LIBERTY NATIONAL BANK AND TRUST COMPANY OF OKLAHOMA CITY, OKLAHOMA, as trustees of the Charles Morton Share Trust, under the provisions of Section 22.0902 (e) of the San Diego Municipal Code, which permit the sale of real property belonging to The City of San Diego by negotiation; and

WHEREAS, the sale of such an interest in real property as this may reasonably be accomplished only by negotiation; and

WHEREAS, this transaction is exempt from the provisions of the California Environmental Quality Act of 1970 under City Guidelines for Implementation of said Act, as amended; and

WHEREAS, the value of the property right sought, as determined by a staff appraiser, is the sum of fifty-five dollars (\$55); and  
WHEREAS, no real estate broker's commission shall be paid; and  
WHEREAS, the sale of the aforementioned property right is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


1. That that certain real property right described in that form of quitclaim deed onfile in the office of the City Clerk as Document No. 747159, be, and the same is hereby authorized to be sold by negotiation for the sum of fifty-five dollars to WILLIAM STITES, GERTRUDE MYERS, C.E. JOHNSON, J.R. HOLDER and the LIBERTY NATIONAL BANK AND TRUST COMPANY OF OKLAHOMA CITY, OKLAHOMA as trustees of the Charles Morton Share Trust.

2. That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk as Document No. 747159, quitclaiming to WILLIAM STITES, GERTRUDE MYERS, C.E. JOHNSON, J.R. HOLDER and the LIBERTY NATIONAL BANK AND TRUST COMPANY OF OKLAHOMA CITY, OKLAHOMA as trustees of the Charles Morton Share Trust, an easement for sewer purposes across a portion of the Northeast Quarter of the Northwest Quarter, Section 11, Township 15 South, Range 3 West, S.B.M., as more particularly described in said form of quitclaim deed.

3. That no broker's commission shall be paid by City on the herein-described sale.

4. That the City Clerk of said City is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
