BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the City Manager be and he is hereby authorized to execute, for and on behalf of said City, an agreement with BOYLE ENGINEERING CORPORATION for engineering services in connection with the design of Imperial Avenue from 32nd Street to Wabash Boulevard, including reconstruction of the existing San Diego and Arizona Eastern Railroad overcrossing.

2. That the expenditure of \$44,500 is hereby authorized out of Gas Tax Fund 220 of The City of San Diego, solely and exclusively for the purpose of providing funds for the above-stated purpose.

3. That it be and it is hereby certified that the information contained in the Negative Declaration on file in the office of the City Clerk as E.Q.D. No. 73-10-008C has been completed in compliance with the California Environmental Quality Act of 1970 and the State guidelines pursuant thereto, and that said Negative Declaration has been reviewed and considered by this Council.
