WHEREAS, The City of San Diego has committed substantial resources to comprehensively planning its Center City; and

WHEREAS, an Urban Mass Transportation Administration (UMTA) application for grant to study the possibility for application of a small scale people mover transit system in Center City San Diego has been submitted pursuant to Resolution No. 208704 approved August 28, 1973; and

WHEREAS, approval of the grant has been delayed because of questions regarding timing of the study and its relationship to regional planning studies; and


WHEREAS, the Center City Urban Design/Transportation Planning Program has been initiated; and

WHEREAS, to proceed in a timely manner with these studies a contract with BRH Mobility Services and \$81,200 from the Transit Reserve Fund 2571 is required; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the City Manager or his representative be in he is hereby authorized to execute a contract with BRH Mobility Services to carry out Phases 2, 3 and 4 of the study for an amount not to exceed \$81,200.

BE IT FURTHER RESOLVED, that the expenditure of up to \$81,200 from the Public Transportation Reserve Fund 2571 in support of the Center City Transportation Planning Program be and the same is hereby authorized for defraying the cost of the contract.
