
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of MARINA S. CUENCA, a widow, executed in favor of The City of San Diego, bearing date of March 19, 1974, conveying to said City an easement and right of way for a public street and incidents thereto affecting a portion of Lot A-258 of Addition No. 7 to San Ysidro, according to Map thereof No. 1500, filed December 4, 1912 in the office of the San Diego County Recorder, as more particularly described in said deed, be and the same is hereby approved, and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named ALVERSON ROAD.

That the City Clerk of said City is hereby authorized and directed to file the foregoing deed for record in the office of the Recorder of San Diego County.

That Resolution No. 206624, adopted by the Council on October 3, 1972, be, and the same is hereby rescinded.
