
Adopted on MAY 9 1974

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. Toro Pacific Distributing 2. Pacific Products, Inc., and 3. Contractor Supply are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of LAWN SPRINKLERS AND PARTS as may be required for a period of one year beginning May 1, 1974 through April 30, 1975, per prices on file in the Purchasing Department as follows:

1. Toro Pacific Distributing for Group I (Toro Sprinklers and Parts), plus sales tax, terms 2% 30 days, prices subject to escalation not to exceed 10%.
2. Pacific Products, Inc. for Group II (Rainbird Sprinklers and Parts), plus sales tax, terms net 30 days, with an option to renew for an additional year. Prices subject to escalation not to exceed 25% for the contract year and 25% for the option year.
3. Contractor Supply for Group III (Buckner Sprinkler and Parts) plus sales tax, terms net, prices subject to escalation not to exceed 30%.
