

RESOLUTION NO. 210549 MAY 9 1974

APPROVING MAP OF CORONADO SQUARE SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by C. J. QUEYREL, a Licensed Land Surveyor, entitled "CORONADO SQUARE Being a subdivision of Lots 23, 24, 32, and a portion of Lot 31 of the Aloha Tract, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 611, filed in the office of the County Recorder of San Diego County, August 8, 1889, together with a portion of an unnamed street adjoining said Lots 23 and 24 as vacated and closed to public use, and portions of Coronado Avenue and 19th Street as dedicated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of 19th Street, for public purposes, and said portion of street is hereby declared to be a portion of a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of sewer facilities, as granted and shown on said map

and subject to the conditions expressed therein.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of a public street is accepted on behalf of the public as heretofore stated; and that that certain easement with the right of ingress and egress for the construction and maintenance of sewer facilities as granted and shown on this map within this subdivision is accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
