The City of San Diego, a deed conveying to the SAN DIEGO GAS & ELECTRIC COMPANY, a corporation, an easement for the purpose of underground electrical facilities across said portion of Lot 3, Block 66, Arnold & Choate's Addition, Map No. 334, as more particularly described in the form of Deed of Easement on file in the office of the City Clerk as Document No. 747314

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
