WHEREAS, The City of San Diego is the owner of certain easements for slope and drainage purposes across Lot 3, G-W Industrial Park Annex, Map No. 7813, by deeds recorded February 24, 1961 as File/Pages 33044 and 33045 of Official Records; and

WHEREAS, the Community Development Department of said City has requested that the City quitclaim to MIRAMAR BUSINESS PARK, a partner-ship, its interest in and to said easements to allow better utilization of the land; and

WHEREAS, no real estate broker's commission shall be paid; and WHEREAS, the sale of the aforementioned property right is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That that certain real property right described in that form of quitclaim deed on file in the office of the City Clerk as Document No. 747318, be, and the same is hereby authorized to be sold by negotiation for the sum of fifty-five dollars (\$55) to MIRAMAR BUSINESS PARK, a partnership.
- 2. That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk as Document No. 747318, quitclaiming to MIRAMAR BUSINESS PARK, a partnership, the easements for slope and drainage purposes across Lot 3, G-W Industrial Park Annex, as more particularly described in said form of quitclaim deed.
- 3. That no broker's commission shall be paid by City on the herein-described negotiated sale.
- 4. That the City Clerk of said City is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
