

RESOLUTION NO. 210567 MAY 9 1974

WHEREAS, Section 21101 of the Vehicle Code of the State of California provides that local authorities may adopt rules and regulations by resolution on the matter of temporarily closing a portion of any street for celebrations, parades, local special events and other purposes when such closing is necessary for the safety and protection of persons who would use that portion of the street during the temporary closing; and

WHEREAS, it is the opinion of this City Council that it is necessary in connection with the Fiesta de la Primavera to temporarily close SAN DIEGO AVENUE from Twiggs Street to Harney Street; NOW, THEREFORE,

BE IT RESOLVED, that that portion of SAN DIEGO AVENUE from Twiggs Street to Harney Street be temporarily closed from 9 a.m. May 17th to 7 p.m. May 19th for the Fiesta de la Primavera.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and directed to post any and all necessary signs and barricades to effectuate said temporary closing.
