
**RESOLUTION No. 210592**

An Act to Amend Section 7090 of the  
Business and Professions Code

Notwithstanding any provision of this Chapter, if the registrar finds that any contractor licensed or registered under the provisions of this Chapter has willfully and deliberately violated any state or local law relating to the issuance of building permits, the registrar shall suspend or revoke the contractor's license. For the purpose of this section, there shall be a rebuttable presumption that construction performed without a permit is a willful and deliberate violation.
