

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$52,651.00 by GFA Electric, a corporation, for MODIFICATION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT THE INTERSECTIONS OF 32ND STREET AND HARBOR DRIVE; AND AT 32ND STREET AND NORMAN SCOTT ROAD/WABASH BOULEVARD, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 746144.

2. That the expenditure of \$68,175.00 is hereby authorized out of Gas Tax Funds (Fund No. 220) of the City of San Diego and that the expenditure of \$3,600.00 is hereby authorized out of Capital Outlay Fund (Fund No. 245) of the City of San Diego solely and exclusively for the purpose of providing funds for MODIFICATION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT THE INTERSECTIONS OF 32ND STREET AND HARBOR DRIVE; AND AT 32ND STREET AND NORMAN SCOTT ROAD/WABASH BOULEVARD in the City of San Diego and related costs.
