

RESOLUTION OF INTENTION NO. 210607 MAY 16 1974

A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE STREET VACATION ACT OF 1941, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE IRONWOOD ROAD SOUTHWESTERLY OF SCRIPPS RANCH BOULEVARD AND FIXING A TIME AND PLACE FOR HEARING THEREOF.

BE IT RESOLVED, by the Council of The City of San Diego, that the public interest and convenience of said City require the vacation of the street hereinafter mentioned; and

BE IT FURTHER RESOLVED, that it is the intention of said Council to order the vacation of IRONWOOD ROAD southwesterly of Scripps Ranch Boulevard, as more particularly shown on Map No. 13147-B, on file in the office of the City Clerk as Document No. 747346.

The Council hereby elects to proceed, in making said vacation, under the provisions of the "Street Vacation Act of 1941."

The Council hereby fixes 8:30 a.m., JUN 13 1974, in the Council Chamber on the twelfth floor of the City Administration Building, The Charles C. Dail Concourse, 202 C Street, in said City of San Diego, as the time and place for hearing all persons interested in or objecting to the proposed vacation.


