BE IT FURTHER RESOLVED, that Resolutions No. 207080 and 207183, previous resolutions regarding the vacation of this alley, which resolutions were continued indefinitely, are both hereby rescinded.

The Council hereby elects to proceed, in making said vacation, under the provisions of the "Street Vacation Act of 1941."

The Council hereby fixes 8:30 a.m., JUN 13 1974 in the Council Chamber on the twelfth floor of the City Administration Building, The Charles C. Dail Concourse, 202 C Street, in said City of San Diego, as the time and place for hearing all persons interested in or objecting to the proposed vacation.

That The Daily Transcript, a daily newspaper published and circulated, and of general circulation, in the said City of San Diego, be, and it is hereby designated as the newspaper in which the Street Superintendent of said City shall cause to be published, in the manner and form required by law, notice of the passage of
