WHEREAS, this Model Cities Program has operated for three action years in the City of San Diego; and

WHEREAS, the Demonstration Program has desirably and effectively improved the living conditions of citizens living in the Model Neighborhood Area; and

WHEREAS, the Council of The City of San Diego desires to continue the City Demonstration Program; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that this Council, for and on behalf of the citizens of the City of San Diego, declares its support for the program and urges the expeditious passage of Federal Community Block Grant legislation utilizing the senate variable entitlement formula giving credit for past participation in Housing and Urban Development categorical programs contained in SB 3066 so that the continuity of the program and its objectives may continue unimpeded into fiscal year 1975.
