BE IT FURTHER RESOLVED, that A STREET between 12th Avenue and vacated 14th Street and between 16th and 17th Streets; and 13TH STREET between Russ Boulevard and A Street, as more particularly shown on Map No. 16041-D, on file in the office of the City Clerk as Document No. 747029, which said map is attached hereto and made a part hereof, be and the same are hereby ordered vacated.

BE IT FURTHER RESOLVED, that the City Clerk shall cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
