

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bids of (a) Cal-Standard Supply and (b) Moline Corporation are hereby accepted, and the City Manager is hereby authorized to execute contracts for the purchase of MISCELLANEOUS PARTS FOR JEFFREY PRIMARY SLUDGE COLLECTORS as follows:
 - (a) Cal-Standard Supply for SECTION I (Sprockets) and SECTION II (Bushings, Bearings and Miscellaneous Parts for a total cost of \$25,480.00; terms 1% 10 days, plus sales tax;
 - (b) Moline Corporation for SECTION III (Chain) for a total cost of \$16,548.10; terms $\frac{1}{2}$ % 10 days, plus sales tax.

2. That the City Auditor is hereby authorized to transfer \$47,191.99 within the Sewer Revenue Fund 506 from the Unallocated Reserve (68.91-3495) to Metropolitan Point Loma Treatment Plant (62.50-2613, \$3,000 - 3310 \$44,191.99) for the purchase of material for the repairs to Sedimentation Basins Nos. 1 and 2.
